Dear Susanne,

Thank you for the minutes of the meeting on 16 Dec .

I feel they fall far short of the mark in terms of content and integrity. I was going to write a detailed reply, but I'm leaving this for my lawyers.

It is incredible that you have managed to hide the police, social services and the school from their parts in creating and substantially adding to the problems for my children. Their involvement is recorded in numerous documents.

Let me make it clear and simple. When social services first became involved in this case (through Chester), it was quite clear that Mrs Dobbie was having an extremely difficult time looking after the children and indeed was giving the children a torrid time in terms of abuse and physical violence - by her own admission, and discussed with social workers and health workers. (not including the copious evidence of Aurora, Graham (her older brother), Lydia (her babysitter and friend), her father (me) and others). At that time the only criticism from Mrs Dobbie, and supported by CHESTER social services was that Mr Dobbie worked too much.

It was agreed with CHESTER social services that Mr Dobbie was in the transition to fully care for the children as Mrs Dobbie could not cope.

6 Months later while protecting his son from yet another attack from Mrs Dobbie, she lied to the police. The police are negligent of not assessing who was the aggressor and caused grievous mental anguish to Aurora and Mr Dobbie by isolating him from the position of primary carer agreed with CHESTER social services. This position of isolation lasted for approx 8 months of torment for Aurora.

When ELLESMERE PORT social services became involved, they behaved in a dreadful manner. They talked openly about Mr Dobbie being a bad man of domestic violence in earshot of Aurora. They then, having declared how they are against Aurora's protector (Mr Dobbie) proceeded to question her, further causing her distress. (DANA and VIVIEN). Aurora openly hates these people. When Mr Dobbie told of the children's distress, EP social services even sent a lawyers letter telling Mr Dobbie not to tell them.

The police created the isolation of Aurora from the only person she trusted. The person who protected her from previous abuse from her mother. EP social services not only backed up the isolation, but proceeded to inform Aurora she was living in a land of lying bullies.

1. The police created and maintained the situation through negligence.

2. The EP social services tortured Aurora by supporting lies against the truth which Aurora had been witness to for a long time. They are guilty of negligence in the duty of care for these children.

There is an awful lot more that could be said; and a lot of recorded detail, and a lot of witnesses. My lawyers will reply.
