Formal complaint.

A boy had put his penis in her face, in her mouth, in her vagina. My daughter was very disturbed by this incident, my daughter's friend (Mya) was disturbed by this event, Mya's mum Sarah was disturbed by this event, the police were informed by Sarah, but mum thought it a minor incident.

This same boy had pestered Aurora for sex on other occasions and mum knew of this, but mum decided it was ok for this boy to be present with Aurora on her own on a number of occasions.

The PPU last week intimated they knew all about it.

The PPU email shows they knew something about it.

COMPLAINT. Why did social services never report this and the other events, which they surely must have known about ?

These show that the mother wittingly subjected her daughter to sexual harassment and degradation on a number of occasions.

The local authority wish the same grossly negligent mother to have sole custody of the children based on their negligent behaviour.

This is a formal complaint that :-

The local authority has known about these incidents and backed putting a child at risk against the requirements of the Children Act 1989.

There is a separate formal complaint already registered with the police.
