1	Mum's lengthy history of hitting and losing her temper and shouting.	Deep mental scars of FEAR on both children.
2	Mum frequently telling Aurora life was better before she arrived.	Aurora low self image and desperation to have a loving mum.
3	Mum's lengthy history of screaming and shouting, banging doors, breaking objects - followed by telling them she loves them.	The children think violent behaviour is acceptable in a domestic environment.
4	Mum's lengthy history of slapping fights with Aurora.	The children think shouting, screaming, banging doors and breaking things is acceptable in the house environment.
5	Mum frequently screams, shouts and hits Aurora during the morning routine. Mum has Aurora crying for years over having her hair brushed or washed.	Both children have love me hate me understanding of their relationship with mum; & possibly others.
6	Mum almost always behaved well out of the house or in front of strangers.	Blurs the boundaries of parental responsibility and shows violence as acceptable.
7		Aurora associates getting ready in the morning for school as a bad time.
8		Aurora associates mum and hair with making her cry and scream.
9		Aurora learned that violence is for inside the family and not to be shown outside.
10	Mum uses the children as pawns in a game of trying to prevent others knowing about her history of domestic violence and domestic abuse.	Mum's instructions to Aurora to tell lies have created a deep distress in Aurora over her loyalties.
11	Mum easily manipulating authorities; social workers and police into believing mum and lying to Aurora	Social workers lie to Aurora and she knows to distrust them and clam up in protective mode.
12	Mum isolating Aurora's family and friends to cover her trail of domestic violence. Mum tells neighbours and other mum's lies about assault. Mum created an extended isolation of the children's father when she was empowered to do so by lying to the police.	Aurora knows these are lies and distrusts those in authority.
13		Aurora knows her mother lies frequently to cover herself. Aurora is inclined to follow this example as she sees social workers and police are easily manipulated by mum
14		Aurora feels isolated and helpless.
15		Aurora distressed at how others see her father. Aurora knows mum's lying yet again.
16		Children manipulated to live without a father. She also minimized contact and spoiled the quality of the contact that was made. Aurora desperately fears losing her father.
17	Mum's lengthy history of negative criticisms of other children and parents	Has left Aurora with negative behavioural traits which have caused her relationship problems with other children.
18	Mum continuously changing her mind in criticizing and praising numerous close people.	Children have difficulty in seeing consistency. Confused by who are friends and not friends. Aurora has difficulty with other children and mum's who are repeatedly criticized.
19	Two year history of deliberately allowing Ken Redman to have abusive power over the children.	Aurora learned to survive in a terrifying hostile environment by keeping out of the way and not saying anything to those she distrusts.
20	Destruction of the children's financial security.	Children's quality of life decreased lots through huge change in family business and loss of car.
21	Lengthy exposure to sexual predator.	Aurora had boy's penis on her face, in her mouth and in her vagina. She is confused about sexual approaches.
