Complaint to the Local Authority Addendum CH16 v2

Dear Sir/ Madam.

This is an addendum to the complaint submitted on 8th April 2013.

The document CHRONOLOGY No1 submitted by the social worker Helen Jones is an act of perjury of the high court in Chester. It is deliberate in its design to make Mr Dobbie look very bad and Mrs Dobbie look very good – contrary to copious evidence. It also contains errors in reported events. It even contains one item that fully contradicts another item about the same subject in her main submission.

At one particular ‘deliberate’ error, Helen Jones reported in the CHRONOLOGY that no sexualised incident occurred between Aurora and Thomas Sinnot. This is in complete contradiction to police records. Helen Jones reports none of Mrs Dobbie’s domestic violence which was evidenced in court.

The cover up of numerous abuses by CSC is further supported by Judith Griffiths who carte blanche dismisses the entire detailed list of complaints as ‘having no factual content’ – even the local authority issuing imprisonment documents never occurred according to her.

I request that the complaint is taken to the next level.

Other authorities have been informed of the extensive and serious level of cover ups conducted by Cheshire West and Chester County Council.

Patrols attended at the address and spoke to Mya Elyce EVANS 13/12/02 that whilst playing at a friend Aurora's (nine years old, surname unknown) house on Saturday 12th March 2011 at , 38 ST ASAPH ROAD, the two girls were in a bedroom with another male visiting the address known as Thomas SINNOTT (believed to be 9 years old) SINNOTT said to the girls "LETS PLAY DARES", SINNOTT said to Aurora "LETS HAVE SEX WITH ME".
Evans did not like this and said stop playing dares.
Thomas pulled Aurora's pants down and tried to lick Aurora's 'Thingy' Evans slapped SINNOTT across the face and said lets stop it now.

SINNOTT pulled his pants down and lay on the bed, he then pulled EVANS neck down towards his willy, he put his willy to her lips. Evans put her head left and right as she was saying "NO WAY".

SINNOTT got Aurora's head to his willy.

EVANS and Aurora managed to get away and then when at the top of the stairs Thomas shouted "DONT TELL ANYONE".

A blue book was obtained as a precaution, which I will retain if required for future evidence.

EVANS is an eight year old girl, whilst speaking to her in the presence of mum and dad she has never heard her daughter speaking in this way and is not very sexually aware, when EVANS was asked what do you think sex means, she said kissing and cuddling in bed. Mum and dad appeared very distraught

38 ST ASAPH ROAD - mum is known as Avril, after checking voters, names linked are Catherine and Thomas DOBBIE.
Mr and Mrs EVANS advised that Avril will be calling police to report the incident involving her daughter.

The father of EVANS attended at 38 St Asaph road and spoke to Avril, who didn't realise the extent of what happened. Mr EVANS obtained the phone number of Liz SINNOTT 01244537818, he called Liz SINNOTT who was of the opinion that it was children playing and that he was making a big deal out of nothing.

There is no trace on CAVA for Liz/ Elizabeth SINNOTT or Thomas SINNOTT.

Please could this be brought to the attention of PPU for them to carry out enquiries with North Wales police.

Risk Assessment

Referral passed to CWAC Social Care for initial assessment due to concerns re sexual harm to Aurora and Mya. A referral will also be passed to their counterparts covering the Deeside area (North Wales) in respect of Thomas' sexualised behaviour.

Whilst all parties are under the age of criminal responsibility there are significant concerns regarding the source of Thomas' behaviour, hence the referral to Deeside. Referral assigned to DS Bluck

Below is the result of the visit with Aurora and what she actually disclosed -

DC Jess Barlow attended address and spoke to Avril and Aurora. I asked Aurora to explain to me what happened when Tom came to visit, and she began to talk about the weekend of the 12th March. She explained that Tom and her friend Mya were playing upstairs in her bedroom,

and that they were all having a nice time until Tom said that he would push her off the bed if she didn't "do something to him". I asked Aurora what Tom meant by this this, and she refused to tell me as she said it was too embarrassing. She did manage to write a few words down which read "Lick my Privates" and "go naked and snog me" and "sex". When I asked her further questions about this, she would not talk about it and became quite upset saying that she had already told her mum what had happened and that she didn't want to talk about it again. Eventually she went upstairs and I spoke to Avril who made it clear that this behaviour from Aurora was very out of character. I asked Avril what Aurora had told her, and she explained that on the evening of the Saturday 12th March after her friend Liz and her son Tom had gone home, Aurora told her that Tom had asked her to kiss his willy and had tried to put her head down there. As a result of this she went to the bathroom and washed her mouth with water as she was disgusted. She also told her mum that he "felt her boobs". Avril explained that the next day, Mya came over to play with Aurora and whilst she was waiting for her to get ready, Avril asked Mya what happened with Tom. Mya explained that Tom pushed her head down towards his privates but she managed to pull away from him. She also said that he did the same to Aurora and that he put his hands down Auroras underwear. Avril said that the school where now aware of the incident and had requested that Aurora may benefit from counselling. Avril stated that she had only she had drifted apart from her friend Liz as a result of previous incidents that she was not happy about. These included a camping trip a few years ago where the children were in a tent and Avril decided to make sure that the children were ok as they were very quiet. As she pulled the zip back on the tent, she saw Tom simulating sex on top of Aurora. Although both children were fully clothed, Avril said that she was not happy with Toms behaviour. She also mentioned an incident where Aurora had told her that Tom took her into some bushes and asked her to take her clothes off. Avril said that she recalled Liz telling her that something had happened at Toms school where a child had complained about him. She could give no further details about this, only recalling that at the time she got the impression that it was of a sexual nature. Both Mya and Aurora have now been spoken to regarding Toms behaviour. Please can all this information be forwarded to the appropriate social care for their attention and consideration.

Attached above is the report sent to Cheshire Police by North Wales Police following their attendance at the home address of Thomas SINNOTT who was aged 9 years old at the time of the allegation sohe was not of an age to be prosecuted.
